You are being invited to take part in this survey because you were recently a patient at xxxx Hospital, having treatment for your cancer. We would like you to answer this questionnaire about your cancer care in the hospital named above, regardless of whether you have received further treatment at a different hospital.

**What is the purpose of the survey?**

## Who is organising the survey?

The survey is being carried out by researchers from Quality Health for the Public Health Agency (PHA) and with the support of Macmillan Cancer Support. Quality Health is an experienced company which specialises in patient surveys in the health service, and it currently works within the health service across the whole of the UK. The results will be presented in a form that does not allow any individual's answers to be identified. The PHA will produce public reports that will include the anonymous survey findings.

## How will my response be kept confidential?

You have been given a unique number just for this survey so that your name and address does not appear on the questionnaire. Quality Health will ensure that data is handled securely and confidentially. At no point in the process will your responses be linked to your name and address and Macmillan Cancer Support will not have access to any identifiable data. Your responses will only be used to provide information about the quality of the hospital's services and to help us to improve these services.

Quality Health will process your answers in confidence. All name and address information will be kept separately and will be destroyed within three months of completion of the survey, unless you agree in question 78 of the questionnaire to be contacted again in future. Your personal data are held in accordance with the Department of Health, Social Services and Public Safety NI document Code of Practice on Protecting the Confidentiality of Service User Information.
